 1. Hasn't lost money – just didn't earn as much as a more aggressive investment.
 2. Expect to return more since interest rates are higher.
 - e. Alma – will some of the profit go back to bursary? Jennifer: that can be discussed as part of next year's plan
 - f. Carol – some questions on formatting and how synchro fundraising is recorded. Why combined with total P&L and not separated- Jennifer: As recommendation can separate in appendix moving forward.
